

## Forest Management Annual Surveillance Audit of RDLP we Wrocławiu located at ul. Grunwaldzka 90, 50-357 Wrocław, Poland September 18, 2019

Introduction - NEPCon is conducting forest management and chain of custody Annual Surveillance Audit of the RDLP we Wrocławiu located at ul. Grunwaldzka 90, 50-357 Wrocław, Poland. The audit will be carried out at the end of October 2019.

Scope of the Annual Surveillance Audit – the forest management Annual Surveillance Audit will assess the environmental, silvicultural and socioeconomic aspects of the forests managed by RDLP we Wrocławiu, using the FSC-STD-POL-01-01-2013. To obtain a copy of the applicable guidelines or to make comments about these standards, please contact NEPCon by telephone, fax, email or website listed below. NEPCon is accredited by the Forest Stewardship Council® and this evaluation process must follow procedures which have been approved. The forest under evaluation contains areas either identified as High Conservation Value Forests or where high conservation values, as defined by the FSC®, are likely found. NEPCon evaluates the identification, management and protection of these High Conservation Values and solicits related comments from stakeholders.

Evaluation Team Composition – The assessment team will be led by Piotr Nowak (Poland). Other auditors: Jacek Ślizowski (Poland), Pawel Synowiec (Poland), Michal Wajnberger (Poland). Technical expert: Zbigniew Sołtysiński (Poland).

Evaluation Steps and Schedule – Following is a short description of the evaluation process and a tentative agenda:

- Evaluation organization NEPCon team will assemble in RDLP we Wrocławiu on the first day of the
- Field evaluation The team will visit sites managed by RDLP we Wrocławiu during the audit.
- Stakeholder consultation Throughout the fieldwork, the team will contact local stakeholders regarding RDLP we Wrocławiu forest management in places surrounding the forest area. This will include private interviews and discussions, and public stakeholder meetings.
- Public stakeholder meetings A public stakeholder meeting will be held in the office of NEPCon Sp. z o.o., ul. Emaus 7/11, 30-201 Krakow, Poland on October 3-4, 2019.
- Final evaluation briefing Prior to departure the team will meet with RDLP we Wrocławiu managers and other parties to finalize their data collection and present preliminary findings.
- Draft report production The assessment team will produce a confidential draft report that will be circulated for comments to RDLP we Wrocławiu. This should occur 28 days after completion of the evaluation.
- Certification decision Upon receipt of comments on the draft report from RDLP we Wrocławiu forest managers and other general stakeholder comments, NEPCon will reach a certification decision. Barring unforeseen obstacles, this should occur not later than on December 22, 2019.

Your Input Sought – As a part of the forest certification evaluation process we invite stakeholders to offer comment and feedback on RDLP we Wrocławiu forest management in relation to conformance with the requirements of the forest management standard referenced above as well as comments on the FME's management and protection of High Conservation Values within the forest under evaluation. We welcome input, either public or confidential, in whatever form is easiest and most secure for you. Your input will be valuable at any stage of the evaluation process, but we would prefer to receive your comments either

prior to the on-site evaluation or during the evaluation so that we can take them into consideration in reaching a certification decision. Your options for communicating your observations to us are as follows:

- 1. Meet with a NEPCon assessment team members during or shortly before the fieldwork.
- 2. Call and give comments to NEPCon staff.
- 3. Submit written comments by mail, fax or email to NEPCon staff. Unless you request otherwise, these comments will be kept confidential and are solely for the purposes of assessing the RDLP we Wrocławiu.
- 4. During the meeting held in NEPCon office on October 3-4, 2019.

The source of any information provided will be kept confidential available only to FSC®, ASI and NEPCon staff.
